- 2. I understand the Prom committee and the xxxx will be organizing bus transportation to the After Prom Party following the Six Schools Prom on May 31, 2018. I hereby acknowledge and agree that the cost of any damage to a particular bus will be shared equally by all of the passengers of such bus irrespective of by whom or how such damage was caused. I hereby acknowledge that the bus company is an independent contractor and that the Prom committee and the xxxxx make no warranty as to the company's qualifications.

I understand the xxxxx Residence contains the following attractive nuisances: swimming pool (two certified lifeguards will be on duty: one from 11pm-2am and the other from 2am-5am), Long Island Sound and assorted equipment and machinery including cars. Except for the swimming pool, I understand that the other aforementioned nuisance areas are not to be used or visited during the After Prom Party. I understand such nuisances may be dangerous. I acknowledge the risk of use of such nuisances, and that the xxxx family and the Prom committee are not responsible for any injuries as a result of the use or misuse of such nuisances.
- 4. I hereby acknowledge, promise and agree that I/my child will not partake in any illegal drugs or drink alcohol while on the bus or at thexxxxx Residence or the After Prom Party and I will not seek to hold the family liable in any way as a result of a violation of this rule.
